Official meetings of the whole association were also suspended though the executive continued to meet in what were very full sessions indeed. There have been plenty of other activities again this summer, chief amongst which were the Referendum on the Zoning and Building By-Laws, Baie d'Urfé Day, the Horticultural Show and the election of our first representatives to the new Baie d'Urfé-Senneville district of the Central School Beard. Because of pressures, both of time and space, some things which ought to have been done in this issue are being left undone but we hope there is health in us and that you will bring them to our attention at the general meeting or in time for our next issue which will come out about the end of September. One of the reasons for apparently unseemly haste in going to press is the departure of the present staff of the Multilith Department at Macdonald College. Don Fuller and Bonnie Fung-Aling have been more kind and helpful than anyone but a harassed editor or committee chairman can know and we wish to pay tribute to their rather amazing readiness to get out your paper at the expense of their own leisure and strength on more than one occasion. Those who know them will join with the editorial staff in wishing them happiness in their new positions.

COUNCIL REPORTS - Selected Items Only

July 5: Present, Councillors Laird, Hanson, Parker, Smith, Sec. Long, Mayor Case and approximately 25 interested citizens. Morrison legal case postponed to July 15th. Approximately 10 new building plans and owners names were tabled and are under consideration by building committee. Connolly subdivision plan tabled and approved. Cape/Allan plan for steel dock at town hall accepted, cost approximately \$250. Council voted \$100 to Joint Hospital Campaign. HORTICULTURE

The annual Flower and Vegetable Exhibition was held under the auspices of the Horticultural Society for the first time this year. In spite of inclement weather, it was most successful from the point of number and quality of entries. Forty-two members and eight children entered 372 exhibits which made a most colorful display and filled the Town Hall. The exhibition has now grown to such a size that additional accommodation will be required next year. The various collections of cut flowers and table centres were cutstanding and showed that considerable trouble had been spent on their preparation. The children's entries were also more numerous than in previous years but there must be many more who could take part and a special effort will be made to bring them in next year. As usual, there were a number of people who were rather doubtful that their produce was good enough to enter and who were pleasantly surprised when they took prizes. In fact, the prizes were well distributed, almost everybody taking some points.

Professor H.R. Murray and Mr. D. W. Pettit of Macdonald College kindly acted as judges and in the evening the prizes were presented by Mayor F. W. Case. The Max E. Binz Trophy for highest aggregate score was won by Mr. & Mrs. Ewing Tait with 31 points. Runners up were Mr. and Mrs. Doug Allan with 27 points and Mr. and Mrs. Reg. Vidler with 19 points. Details of the results are given below.

In view of the fact that the society was started rather late in the season, the Executive Committee decided that there was little point in affiliating with the Quebec Horticultural Federation. A society must be in operation before May 1st to participate in the grant from the Provincial Government. However, application for membership in the Federation will be made at the beginning of the 1951 season.

The following seed houses will extend discounts to our members upon presentation of membership cards. Where orders are being mailed, they should first be stamped on behalf of the society by the secretary, Miss Joyce Hartnell, 43 Oxford Rd., Phone 2944. The society has arranged to buy fertilizer and peat moss for its members at wholesale prices by pooling orders. Reduced prices can also be obtained on general purpose and dense shade types of grass seed if there is sufficient demand. For information call Ewing Tait, Phone 876. Orders should be placed with him by Saturday, September 9th.

During the coming winter there will be moving pictures and talks on gardening. It has also been suggested that a lecture course on fundamentals be held again, with discussion groups on individual and local problems.

TOWN PLANNING - A REPORT OF PROGRESS

It is more or less ancient history that the referendum on the Zoning and Building By-Laws, which were the first step towards our Town Planning, was held on August 11th and 5th and that the vote recorded showed 97 in favour of the by-laws and 7 against. The tremendous amount of thought and time which preceded this recording of opinions is well known to most of us, and the indefatigable efforts of Dr. Hanson, Doug Laird and Mayor Case and others are gratefully acknowledged. Newer developments may not be so well known. All applications for building of any sort are now accompanied by a non-returnable fee of \$5.00 and the plans surveyed by a building inspector and building committee. If accepted, a new permit fee is charged as follows: \$25 plus \$1 per thousand for certified cost of building for residences and \$5 plus \$1 per thousand or less for accessory buildings. The Town Council has appointed Mr. Gordon Bryson as building inspector. Mr. Bryson is in his last year of architecture and has experience in construction work which makes him particularly well qualified for his post. He plans on becoming a resident of Baie d'Urfé.

Next month the building committee and Mr. Bland begin to develop further planning within the zones including such things as parks, playgrounds, safety zones and homologation of roads.

SCHOOL AFFAIRS

The election for school commissioners for the newly formed Baie d'Urfé-Senneville district took place on July 17th and the nominees chosen at the June meeting of the Citizens' Association were elected. TAXES VS. VOLUNTARY FINANCING

Much has been said, here and there and over the past few years, on the values of financing community projects through taxes, or alternatively, through voluntary methods. There are those who are strongly in favour of one method, there are those who favour the other, and there are those who think a compromise is to be desired. The time appears ripe to bring the subject into open discussion for the decision of the citizens in general and hence for your executive's guidance as well as the council's benefit in managing our town.

Many improvements are either in effect, going into effect or in the wishful thinking stage of "let's do something about it". These improvements all require money, time, effort, if we are to continue with our plan and make Baie d'Erfé the kind of place we want to live in and raise our children in. In order to carry through your wishes for wharves, playgrounds, parkways, tennis courts, club house, better roads, trees, new by-laws, etc. and the resultant maintenance and supervision, we must all decide how to finance these projects over and above the free time and effort available.

Mr. Henry McKee, our Treasurer, will prepare a simple method for us to use in judging the cost per taxpayer if a project is to be financed via taxes. He will also show you the cost of running major items of your Baie d'Urfé Citizens' Association, such as News and Views and Baie d'Urfé Day which are outgrowing us and becoming an accepted part of the town.

We ask you all to think over this article and come in full force, as this is the main topic at our September meeting.
