BAIE D'URFÉE - A DESIGN FOR LIVING!

As all residents are aware, Baie d'Urfée has been growing like mad. Last year some 100 building permits totalling over \$1,000,000 were issued and this year the growth promises to be even greater. Almost overnight, farmland and empty fields are vanishing as one lovely home after another springs up. In five years, it is predicted, if demand for homes and building continue at this dizzy pace, there won't be a vacant lot in Baie d'Urfée south of the metropolitan highway.

Ninth Year No. 89 Naturally, this building is not going on in haphazard fashion; it is going on according to plan, and in keeping with zoning and building by-laws of the community. It is going on only with the approval of town council after investigation and recommendation by councillors specifically concerned. Harry Smythe is in charge of town planning, and he will tell something of town planning in Baie d'Urfée, past, present and future, at the next meeting of the Citizens' Association at The Coop, Friday, May 13. Come on out and perhaps get a sneak preview of the Baie d'Urfée of the future.

NEW, LESS CONTROVERSIAL BUILDINGS INSPECTOR SUGGESTED

Speaking on behalf of the executive of the Baie d'Urfée Citizens' Association, Jack Mitcham, chairman, suggested to town council Tuesday, May 3, that it was fair neither to C.O. Grimm nor to the town that Mr. Grimm should continue as town buildings

inspector.

Such a dual capacity--being at the same time real estate operator and buildings inspector--was not a happy situation, suggested Mr. Mitcham and it was an untenable position in which to place any man. "Inevitably," he said, "Mr. Grimm the realtor may one day have to compromise Mr. Grimm the buildings inspector, or vice versa."

Mr. Mitcham said the executive felt council should be made aware of the fact there was a certain amount of nasty talk going about, which reflected credit on neither Mr. Grimm nor the town. It could be eliminated immediately by the simple expedient of council appointing to the inspector's job someone whose personal business activities were not so closely related to it. Mr. Mitcham said it had been understood that Mr. Grimm's appointment was supposed to be temporary, anyway.

In speaking to council, Mr. Mitcham said that in fairness to Mr. Grimm and all concerned he wanted to set the record straight with regard to his previous appearance before council in committee a month ago. A report in a Montreal daily had said the Association had confronted council with an ultimatum concerning the buildings inspector following a "quiet investigation." This was not so, said Mr. Mitcham, and he went on to explain, in public, what he <u>had</u> told council.

The Association was making no allegations of abuse of office, Mr. Mitcham said, but the number and variety of complaints concerning building in Baie d'Urfée indicated a growing dissatisfaction with the present buildings-inspector set-up. A change seemed to be warranted, and council was asked if it was planning a satisfactory solution to the problem.

Mr. Mitcham said his appearance before council had been simply the Association's attempt to fulfill its obligations and "to cooperate with council in promoting the general interests and welfare of the community" by acquainting council with a controversial issue before, rather than after, it reached the point of public debate.

"Has council considered the situation and have they any announcement to make at this time?" asked Mr. Mitcham.

Mayor Gelinas thanked Mr. Mitcham for his statement and his efforts to correct the Montreal newspaper account, pointing out that such publicity reflected on all people conducting the town's affairs. Mayor Gelinas said council had taken no action other than that two citizens--John Fisher and Ted Pilkey--had been nominated at a Citizens' Association meeting to assist Buildings Chairman Al Christie in the consideration and inspection of building plans. Thus there could be no question of improper partiality in the approval of plans.

"The Association appointed the two--not me," said Mr. Christie. "And, incidentally, there was never any favoritism; on several occasions plans submitted by Mr. Grimm have been rejected, as well as others."

"Then that is the extent of council's action at this time?" asked Mr. Mitcham.

"Yes," replied the mayor.

Chairman Mitcham will report on the steps taken by the executive, and the council's reaction, at the next Citizens' meeting.







Skating Rink

According to present plans Macdonald College will build an artificial ice skating rink this summer for use next fall. As a result of negotiations between the College and the Central School Board it has been decided to build the rink on land to the North East of the School on which the school has right of lease. The Board will contribute toward the operating costs and the school will have certain periods allotted for the children and for school hockey.

An area to the North of the School will also be relinquished on lease by the College for a junior playground for small children.

Central Board Representation


Due to the rapid growth of Isle Perrot and the intention to build a school there, the Isle Perrot Board wish to elect their own member to the Central Board instead of having joint representation with Dorion. Since there cannot be more than five members, and since Baie d'Urfée-Senneville insist on retaining three members, the Central Board has recommended to the Department of Education that St. Annes relinquish their membership in favour of Isle Perrot. St. Annes and Dorion would then jointly elect a member. This proposal is supported by the Boards of Baie d'Urfée, Senneville and Isle Perrot and opposed by Dorion and St. Annes. The matter is now in the hands of the Department.

WOULD CURB DOGS RUNNING LOOSE

Fourteen building permits totalling an estimated \$199, 319 were issued in April, Buildings Chairman Al Christie reported to town council May 3. Mayor Gelinas was in the chair.

Mr. Christie said the permits included 11 homes, one extension, one alteration and one greenhouse.

He said heavy vehicular activity, such as big trucks, bulldozers, steamshovels, etc., had been banned from Baie d'Urfée roads until frost was considered entirely out of the ground.

Councillor George Jost raised the question as to how to handle the pending \$34,000 bond issue, whether by public tender or through the local branch of the Bank of Montreal. Although the bank was prepared to take the issue, and had submitted an offer, council felt they would be inviting criticism if competitive bids were not sought. Tenders will be sought.

Mr. Jost said 1955 tax collections to date totalled \$12,000, or approximately 46 per cent. Mr. Jost said Macdonald College fire equipment was now available to Baie d'Urfée, but the formal, final agreement had not yet been signed. It looked now, he said, as though there would not be an extra \$1000 insurance premium (which Baie d'Urfée would pay) because Macdonald was going to make serviceable a second piece of equipment not in use previously. Mr. Jost said there would be extra public liability insurance, however, cost of which the town would have to bear, plus a nominal charge for each run to Baie d'Urfée.

Councillor Harry Smythe said complaints had been received about dogs running free about the town. He felt there should be a by-law concerning keeping dogs under control, and presented a proposed by-law for consideration. Here it is:

"The owner of a dog found running at large anywhere in the town and not in charge of any person during the period starting at 12 o'clock noon on April 15 and ending at noon on October 15 of each year, or which is objectionable or a cause of public nuisance, shall be liable to the fine hereinafter provided.

"If a dog bites or attempts to bite any person, it shall be considered as dangerous and shall be muzzled and in the event of the owner of said dog failing to comply with this by-law he shall be liable to the fine hereinafter provided.

"The word 'dog' wherever it occurs in this by-law shall be considered and take in its general sense."

Secretary Treasurer Soucy reported that the provincial police declined to act in a situation presented by George Buch and had suggested that council look into it.

Mr. Soucy said the bill of \$4666 for the new transformer had arrived, but the transformer was not yet in operation. This was because the hydro hadn't completed the new sub-station. Councillor Corbett noted that Quebec Hydro, not ready yet, had been very insistent that the town have its transformer ready by November, 1954.

Council approved payment of \$2605 to the firm who carried out the reassessment and prepared the supplementary roll. The charge was broken down as follows: actual charge for roll and supplementary roll - \$1250; 96 new buildings at \$7.50 each -\$720; 254 lots at \$2.50-\$635. This was in accordance with an agreement approved last year.

Reg Vidler presented a street light broken by gunfire, either .22 or BB, and said some 35 had been shot out in the past year. This was not only dangerous but expensive. Councillor Corbett suggested that the broken lights go unreplaced and as it got darker and darker, parents would complain and perhaps do something about their youngsters and their BB guns. Perhaps the Citizens Association would like to go into the situation.

TWO CITIZENS TO AID CHRISTIE ON BUILDINGS

Baie d'Urfée Citizens' Association met April 15 at the Coop. Chairman Jack Mitcham confirmed that the Baie d'Urfée birthday party would be held April 30.

<u>Coop</u>: Jack Mitcham said the semi-public telephone would be installed within the next two weeks. The chairman also summarized his letter to town council asking for a 50 per cent contribution for current Coop improvements and alterations. Town council has agreed and their grant will be approximately \$300., one-half of the estimated \$600 cost. (It has now been received.)

<u>Combined Appeals</u>: Ruth Tait reported that 40 canvassers worked on the appeal, making 313 calls and obtaining 258 subscribers. Total collected for the five agencies was \$2207, \$750 more than last year. Ruth expressed great appreciation of the canvassers and for the assistance rendered by Harry Dixon, Reg Vidler and the Citizens' Assoc.

<u>Coop</u>: The chairman said Coop operations cost per month was about \$75, of which \$25 was defrayed by revenue.

Recreation: Bill Norcott said one lifeguard was lined up for the beach and he intends to get a second man to help on weekends.

Water Pollution: A discussion took place with Bill Norcott, Herb Brookhouse, Ted Pilkey and others taking part. The conclusion was that it is questionable whether the degree of pollution is dangerous to health. Herb Brookhouse said efforts were continuing toward reducing pollution but this was a complex matter because several municipalities were involved.

<u>Coop</u>: Bob Higman said the outdoor coloured lights needed rewiring and some new sockets. Reg Vidler mentioned the post in the "square" outside the Coop and suggested its removal before it gets used for supporting the telephone wires. Charlie Johnson was asked to take care of this matter. On a suggestion by the chairman, it was moved and seconded by R. Vidler and George Moore that this building be named (officially) "The Coop". Carried. It bears the number 20601 Lakeshore Road.

Boy Scouts: Chairman presented a suggestion from Brad Proudfoot that a Baie d'Urfée Scout Troop be formed. A scoutmaster and assistant are needed and he called for volunteers.

New Member Frank Reese and visitor Mrs. Mitcham were introduced.

Town Council: Councillor Al Christie requested the help of two citizens on the building committee for the summer. Ted Pilkey, and John Fisher, nominated from the floor, accepted.

Town Finances: Chester Ellis asked for clarification of the town's finances and requested that the financial statement be published in "News & Views", Chairman said it was intended to do so.

Town Planning: Chester Ellis asked if the new town plan in the town hall was official and if so how and when it had replaced the previous plan in which Prof. Bland had participated. Sid Nagley questioned the official status of the previous plan and Councillor Brookhouse explained that the new plan was drawn up under the supervision of the engineer retained by the town and represents the town as it is. This new plan and apparent trends differing from the previous plan were questioned. Councillor Al Christie reviewed past and future plans and subdivisions and said Prof. Bland's plan was a guide rather than a precise layout. He added that if a subdivider complies with building by-laws the town would find it difficult to reject his plan.

Al Davis asked who the town's engineer was and who decided upon location of new roads. He suggested that the town prevent through-ways. Al Christie replied that the subdivider included roads in his plans but these were subject to the approval of Councillor Harry Smythe. He also pointed out that turning space for a snowplow in winter is necessary and dead-end roads do not permit this. He remarked that most planned roads had curves. The chairman noted that this was a subject of considerable importance and should be discussed more fully soon. Chester Ellis suggested that the new plan be published in "News & Views" and Al Christie suggested that its discrepancies be pointed out first. Al Loke and Al Davis moved town council be asked if this is a master town plan.

<u>Coop</u>: Chairman Mitcham said two of the murals by Bob Buckham for The Coop were ready.

Town Elections: Chester Ellis asked if the Association was doing anything in preparation for the forthcoming elections. Chairman said question of a nominating committee would be discussed before the summer lay-off.

Post Office: The Chairman introduced this subject by reading from "News & Views" and elaborated on the general problem of the need for new post office facilities, preferably away from the Town Hall where space was limited. Post Office regulations were explained with the help of E.M. Corbeil, Superintendent of Postal Services Montreal area.

Various methods of delivering mail were discussed. House delivery was declared impossible by Mr. Corbeil, even if Senneville, Ste. Anne's and Baie d'Urfée were considered together. Rural mail delivery appeared impractical, and drop boxes also. With rural delivery, Mr. Corbeil explained, all boxes would have to be located on the main road.

Sid Nagley and Al Loke thought the matter should be left in the hands of the Post Office.

Councillor Herb Brookhouse recommended that the post office be relocated in a small building on the Coop site, thus relieving the congestion at the town hall. Chester Ellis suggested that space used by the town Secretary and post office be interchanged, then moved that space in the town hall be realigned to accommodate both the Secretary and post office. Carried. The meeting concurred that if the work of a town employee was being interfered with by extra, outside duties, then it was council's duty to make other arrangements.

TOWN COUNCIL MEETING TUESDAY, APRIL 12, 1955

PRESENT: MAYOR Gelinas, ALDERMEN Christie, Corbett, MacLeod, Brookhouse, Jost.

In attendance: Messrs. Long and Soucy.

The registration of a sub-division of 46 lots in Lakeview Gardens was approved in principle, subject to check of the plan against the book of reference.

A revised plan of a new house, designed by Steve Albulet was approved and a building permit will be issued.

It was agreed that extensive alterations will require a building permit rather than an alterations permit. The case in point is a residence on Morgan Road where the addition will exceed the size of the original structure.

It was agreed that in future contractors will be asked to submit a plumbing sketch with their plans.

A new park area of approximately 100,000 square feet, to serve the Oakridge and Vistarchi Developments, will be secured by trading present unsuitable area on Oakridge grade.

Mr. Soucy will ask Provincial Police to investigate George Buch's complaint regarding a neighbour's dog.

Council decided not to appeal the Superior Court decision in the Carriere case rendered in favour of the plaintiff. Although Mr. Long expressed the opinion the Town possibly had better than a 50-50 chance of reversing the decision, the aldermen voted three to two against appeal on the basis of -

- (1) Cost (an additional \$1,500 over the \$700 already spent in this case if the Town lost the appeal.)
- (2) It will not necessarily establish a dangerous precedent since it would appear the trial judge erred in fact, and
- (3) The proposed extension of greenhouse activities is considered objectionable by only a very few citizens.

Negotiations with Macdonald College to complete arrangements regarding use of their fire-fighting equipment is progressing satisfactorily, according to Councillor Jost.

Civic No. 20601 Lakeshore Road was assigned to the Baie d'Urfée Barns.
